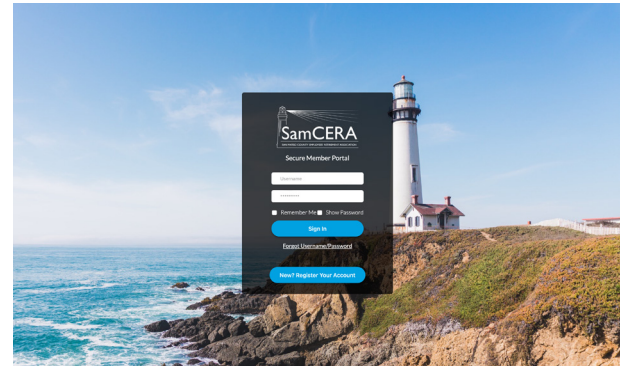


MySamCERA Member Portal: Register for a New Account

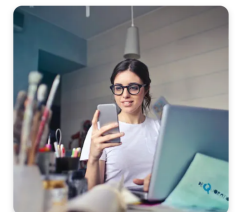
